## MEMORANDUM OF UNDERSTANDING

BETWEEN

the **NATIONAL TAIWAN UNIVERSITY OF ARTS**

the **HUNGARIAN UNIVERSITY OF FINE ARTS**

In the spirit of friendship and with mutual interest in cooperation, the **National Taiwan University of Arts, New Taipei City** and the **Hungarian University of Fine Arts, Budapest** enter into this Memorandum of Understanding (MoU) to promote joint educational and cultural collaboration and agree as follows:

### ARTICLE 1: SCOPE OF COLLABORATION

1.1 Either Institution may propose areas of collaboration including:

- Academic exchange between BA and MA students, professors and technical staff from the departments of Painting (Intermedia and Printmaking modules included), Sculpture and Graphic Design – by establishing a student exchange program, in particular for young researchers including the exchange of academic credits.
- The promotion and facilitation of the exchange of teaching and research personnel in order to contribute to the improvement of the quality of teaching and research in the area of Fine Art and Graphic Design;
- Promoting joint faculty and scholar activities;
- Supporting the participation in conferences, forums; cultural activities, events, concerts, festivals; joint projects;
- Improvement of the international mobility recognition.

1.2 Any specific activity developed under this MoU shall be detailed in a subsequent agreement signed by each Institution's authorizing signatory.

1.3 All activities shall be subject to the availability of funds and the approval of each Institution's authorized representatives. In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party, as well as the various aspects of any possible outcome (e.g. intellectual property, patents, copyrights, commercialization of the outcome, etc.) will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the program.

## ARTICLE 2: DURATION AND AMMENDMENT

2.1 This MoU shall take effect when signed by the authorizing signatories of both Parties. It shall remain in effect for a period of 5 years and can be renewed at the discretion of either party. Either party may terminate this Agreement at any time. The effective date of termination is the end of the academic year immediately following the notice. The Agreement can be amended at any time by written agreement duly executed by all parties. If this agreement is terminated, neither the **National Taiwan University of Arts** nor the **Hungarian University of Fine Arts** shall be liable to the other for any monetary or other losses which may result from such termination.

2.2 Amendments to this MoU may be requested, in writing, by either Institution and shall take effect following official approval by the authorizing signatories of both Institutions.
